2016 UPDATE from the Board of Directors:

We hope our new Newsletter will help better communicate our plans and current actions that your Board of Directors have taken to improve our association, to meet our goal of increasing the equity in your real estate.

Over the past several months, we have taken corrective action to stop flood waters from entering and degrading roads and the airstrip. This was accomplished by negotiations with Nye County to divert water before it entered our development. This project has taken about 7 months to accomplish and we are very

grateful to the County for doing it. It was a large undertaking that we not only could not have afforded, but we also did not have the authority to accomplish it on our own. We have also cleaned out our bar ditches and installed some culverts on the east side of the airstrip to manage the flow that will continue to runoff down the mountain during heavy rains. You will be pleased to know that so far it all seems to be working smoothly. That is saying a lot in the El Nino conditions we have been experiencing this Winter.

We have also done some long needed maintenance on our community property, specifically the runway, taxiways and clubhouse. Tackling this deferred maintenance has not only improved the attractiveness and appeal of our association property, but has also addressed some serious safety issues that could have cost us dearly. It was unsettling to have the risk management issues associated with these safety issues.

Getting WATER to the Eastside lots and upgrading existing water infrastructure:

We have recently opened preliminary conversations with Utilities, Inc. (our area water provider) to see if there is a way to get them to service the Eastside lots in a manner that is affordable. This will likely be a process that takes several years to accomplish, but our initial meeting was very positive and they are moving us up on the priority list now. The plan that Utilities, Inc. has set proposed is to model a future design that would supply water with a secondary well, tied into the existing Westside well. This



would require upgrading our existing outdated system and bringing it up to current code so that our fire safety requirements could be met. As we get a clearer plan, costs, and timeline will report back with these details.

We do want to emphasize that some lots on the Eastside of the airstrip are being built on. We already have many hangars on the Eastside and the owners are very happy using them. Power is addressed with a combination of solar power and generators. Some properties have installed septic tanks with permits from the State. These owners transport water to use in their hangars or hangar homes. This is the choice they made to work around the obstacles of not having onsite utilities and it seems to be working well for them.

Additional Comments from the Board:

In December, the three current board members (Roy, Steve and Joan) were the only ones to volunteer to run for the Board election for 2016. Since only 3 nominations were received, there was no requirement for ballots to be sent out as no vote is needed to fill the three positions. Our goal is to continue what we started in 2015 and try to better manage our association and improve our unique community. We pledge to continue working hard to improve everyone's equity and manage the airpark in a cost effective way that ensures safe operations and a facility you can be proud to be an owner of. We wish you a healthy, happy and productive new year!
